HOW TO REACH US

It takes about 20 minutes to get to the Department of Law from the railway station, if you go walking. Otherwise, you can take a bus: use line 1, line 6, line 9 or line 21 and stop at '*Giardini - viale Cavour*', or use line 21 and stop at '*Cavour barriera*', or line 3C and stop at '*Contrada del Mirasole Arianuova*'.
